## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter called "MoU") is made at Lahore on this 7<sup>th</sup> day of December 2015;

### BETWEEN

Chughtais Lahore lab (Pvt) limited having its head office at 10-Jail Road Main Gulberg Lahore, acting through its chief Executive Officer (hereinafter referred to as 'Chughtais Lahore Lab (Pvt) Ltd' which expression shall, wherever the context requires or permits, include its successor in interest, legal representatives and permitted assigns) of the first party;

### AND

Punjab Teachers Foundation acting through its Managing Director, having its registered office at Rahman Arcade, 36-E Court Street, Lower Mall, Near Civil Secretariat Punjab, Lahore (hereinafter referred to as 'PTF' which expression shall include its successors in interest, legal representatives and permitted assigns) of the Second Party;

'Chughtais Lahore Lab (Pvt) Ltd' and 'PTF' shall hereinafter collectively be referred to as "Parties" and individually as "Party"

**WHEREAS**, it is the intention of the Punjab Teachers Foundation to provide platform and opportunity to dependents and beneficiaries of the PTF to avail discounted medical test facility to be provided by Chughtais Lahore Lab (Pvt) Ltd.

**NOW, THEREFORE**, in consideration of the mutual covenants hereinafter contained, the Parties hereto agree as follows:

1. Chughtais Lahore Lab (Pvt) Ltd offer to PTF, its beneficiaries and their dependents 20% cash discount on their standard market rates on all medical tests/investigations;
2. "Beneficiaries" means serving or retired teachers of the Government of the Punjab, Education Department and "Dependents" means the wife/husband, dependant parents, dependant sons and un-married daughters of the beneficiaries;

3. Medical tests/investigations can be availed from any of the centers of Chughtais Lahore Lab (Pvt) Ltd across the country;
4. Discount facility will be provided to beneficiaries on showing or presenting PTF authority letter/reference slip duly signed by the authorized person/Registration Card issued by PTF;
5. Implement the MOU at a Regional and Local District/Tehsil Levels using agreed protocols, communication, monitoring, review processes and capacity to utilization of all available existing resources;
6. PTF only assist teachers but can never legally bound or restrict to make test/investigation at the centers;
7. Tests/Investigation rates so quoted, if revised, prior submission to PTF office is necessary;
8. Attested copy of rates duly signed by MD, PTF regarding all the Tests/Investigation provided to PTF should be displayed at all centers/Labs of Chughtais Lahore Lab (Pvt) Ltd;
9. Issues relating to service delivery requirements should be resolved at the most local level possible within an agency, in the earliest possible time. If these efforts are not successful, regional/area protocols are to be used to resolve issues;
10. Chughtais Lahore Lab (Pvt) Ltd will never use this MOU for getting any unfair-mean publication.

### **PURPOSE**

This MOU describes the collaboration and responsibilities of the participating organization to provide needed medical test facility and services on discounted rates to all the Punjab Government Teacher's community and their dependents as well as employees of the PTF.

### **FUNDING**

Cooperative activities under the MOU shall not involve any commitment of Funds and/or resources. This MOU shall not be construed to obligate any particular expenditure or commitment of funds and/or resources. Funds and/or resources may be provided by either party to the other party to support activities under this MOU.

Chughtais Lahore Lab (Pvt) Ltd will never demand any payment from PTF against any particular medical tests/investigation provided by it to teachers of Punjab Government, staff of PTF and their dependents.

PTF is sole responsible to look after privileges/discount offers to beneficiaries and their dependents regardless to financial implication i.e amount disbursement and bill payment.

### **AGREEMENT PERIOD**

This MOU becomes effective on the date of the last signature. This MOU will be reviewed periodically as necessary, and may be modified in writing at any time by mutual consent. Either party may terminate this MOU by giving 15-days notice in writing.

### **NON-BINDING LEGAL NATURE**

The parties hereby acknowledge and agree that the MoU is not legally binding to them.

The parties have no intention to create and nothing herein shall be construed as creating, legal rights and obligation or any commitment whatsoever.

### **GOVERNANCE & EVALUATION**

The Managing Director, PTF and the Chief Executive Officer of the Chughtais Lahore Lab (Pvt) Ltd will meet at quarterly intervals to discuss progress and issues relating to the objectives/consideration set out in the MOU.

PTF and the Chughtais Lahore Lab (Pvt) Ltd will appoint a senior responsible officer from each organization to work together to ensure that the deliverables are achieved.

The effectiveness and impact of the MOU will be reviewed annually.

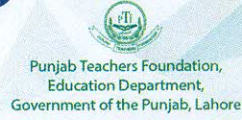
